



COVID-19 SELF-SCREENING QUESTIONNAIRE AND LIABILITY RELEASE

ALL ATTENDEES MUST read AND answer the self-screening questions below before departing for, and upon arrival at, the 2021 NABC Gateway Pars for Cars Golf Fundraiser ("Golf Event"). You agree that you will not attend the Golf Event in-person if the answer to any of the following questions is YES.

LIABILITY RELEASE

Those choosing to attend the 2021 NABC Gateway Pars for Cars Golf Fundraiser (“Golf Event”) in-person on September 13, 2021, at the Boone Valley Golf Club, Augusta, MO (“Course”) must agree to the terms of this Assumption of Risk and Waiver of Claims (“Waiver”).

Attending the Golf Event during the ongoing COVID-19 pandemic carries risk due to the contagious nature of the virus and the fact that there will be a large number of attendees. The undersigned (“I”) have made the decision to attend the Golf Event with the full understanding of the inherent risks of such decision and agrees as follows:

- I am attending the Golf Event at my own risk and understand that by attending I risk being exposed to or infected with COVID-19 as a result of my actions or those of other attendees or participants including the Course’s employees and NABC’s officers, directors and staff. I understand that neither NABC nor the Course can prevent me from being exposed to, contracting, or spreading COVID-19 while attending the Golf Event and related events.
- I hereby release, for myself, my heirs, and personal representatives, and do forever discharge, indemnify and hold harmless NABC, its directors, officers, staff, agents, members, and representatives, from any and all claims, liabilities, actions, damages, costs or expenses of any kind arising out of, in connection with, or relating to my attending or participating in the Golf Event including, without limitation, any illness, damages, or injury resulting from my travel to and from, and attendance at, the Golf Event, participation in events related to the Golf Event, exposure to an infectious disease (including COVID-19) or the manner in which the Golf Event or its related events and activities are conducted.
- I will follow all required health and safety guidelines, protocols, policies, regulations, and mandates while attending the Golf Event, including those implemented or recommended by NABC or the Course (regardless of whether federal, state, or local laws dictate otherwise), or by federal, state, or local authorities (collectively, “Guidance”) which may include (among other actions) wearing a face mask or covering while attending Golf Event meetings and events and maintaining appropriate social distance from others.
- I agree to monitor my own health status and will not attend the Golf Event if (i) I am symptomatic of COVID-19 in any way (even if I am fully vaccinated against COVID 19); (ii) I believe I have been exposed to or been in close contact with someone with COVID19 in the 14 days prior to the Golf Event (unless I am fully vaccinated); (iii) I have had a positive COVID-19 test for active virus in the 10 days prior to the Golf Event or, at the time of the Golf Event are awaiting results of a COVID-19 test; or (iv) a public health or medical professional told me to self-monitor, self-isolate, or self-quarantine because of concerns about COVID-19 infection with the 14 days prior to the Golf Event.

NOTE: Close contact is being within 6 feet for 15 minutes or more over a 24-hour period with a person; or having direct contact with fluids from a person with COVID-19 with or without wearing a mask (i.e., being coughed or sneezed on). People are considered fully vaccinated (i) 2 weeks after their second dose in a 2-dose series, like the Pfizer or Moderna vaccines, or (ii) 2 weeks after a single-dose vaccine, like Johnson & Johnson’s Janssen vaccine. If it has been less than 2 weeks since your final dose, or if you still need to get your second dose, you are NOT fully protected.

I understand that NABC is under no obligation to provide medical aid in case of accident or illness during the Golf Event. However, should an accident or illness occur, I give NABC (its representatives or staff) permission to seek immediate medical aid, and I further agree to hold harmless NABC and its respective officers, directors, staff, agents, members, and representatives from any liability for illness, death, injury, loss or damage related in any way to the provision, or lack of provision, of medical aid.

I affirm I have carefully read this Waiver, understand its terms and conditions, and agree to be bound by all of its terms and conditions.
